*Must have completed a Certificate III in Commercial Cookery or similar qualification leading to the occupation outcome "Chef" through an apprenticeship pathway only. These fees are estimates only for students enrolling in government funded courses in 2021 on a full time basis. The indicative fees for a course may differ between training providers due to the units they have included in the course outline. These differences generally result from adapting courses to meet local industry needs. Concessions and annual course fee caps may also apply to some courses. Fee caps are only shown on the basis that all units are commenced in 2021. Fee caps apply to some tuition fees only. The maximum course fee for non-concession students undertaking a targeted fee relief course in 2021 is \$1,200. For concession students and youth, the maximum course fee for undertaking a targeted fee relief course in 2021 is \$400. These maximums apply per course in 2021. For secondary school aged persons (in 2021, students born on or after 1 July 2003 who are at least 15 years old) undertaking training that is not part of a VET in Schools program, the maximum course fee chargeable in 2021 is \$420 plus the resource fees and discretionary fees. Fees have been quoted on the basis of 2021 fee rates only. These are expected to change in 2022. Other charges may apply. In some instances the fees for a course may contain units from the next lower level, if you have already completed those units in the lower level, your fees will be less. In some instances a course may allow direct entry, but have required units that are included in the next lower level which are not included in the displayed fees. If you have not already completed those units in the lower level, your fees will be higher. The student tuition fees are indicative only and are subject to change given individual circumstances at enrolment. Additional fees may apply such as student service and resource fees.
